Companion-Pet Bill of Sale

This sales agreement refers to a (fe)male Welsh Springer Spaniel whelped _____, 201X, sired by Ch _____, [AKC Reg#], out of Ch _____, [AKC Reg#]. This puppy is being sold as a companion (pet) (fe)male and is to be registered with a LIMITED registration, making it ineligible to be used for breeding purposes. Possession of the AKC papers is to remain with the breeder contingent upon completion of spay/neuter procedure and OFA hip/thyroid reports, and a copy of the papers will be provided to the owner for purposes of health testing at a later date. This puppy is being sold for the amount of \$XXXX and the breeder will maintain co-ownership of the dog for a period of time, as described above. Every effort has been made to breed a healthy dog from sound and healthy stock. Development of hip dysplasia, epilepsy, eye or thyroid disorders, or other health problems cannot be predicted by the breeder at the time of sale.

The breeder make no guarantees regarding any hereditary or congenital defects of the puppy not noted on the health certificate. The puppy is to be examined by a licensed veterinarian within 7 days of sale, with all veterinary costs to be borne by the buyer(s). Should any health issues be identified at that time, the breeder is to be notified immediately. Should the owner decide not to keep the puppy within 7 days of sale, the puppy may be returned for a full refund of the purchase price by [Date 7 days from date of sale]. Should the dog develop epilepsy or hip dysplasia severe enough to warrant euthanasia before [Date 5 years in the future from birthdate], a replacement of the dog with one of similar quality shall be made after receipt of veterinary proof of euthanasia. The decision regarding timing of the replacement rests with the buyer(s), and is dependent upon breeding plans of the breeder.

The buyer(s) agree(s) to have this dog receive all normal vaccines and veterinary care, including heartworm and parvovirus preventatives, tick and flea control, and Lyme's disease vaccine in endemic areas. In addition, the buyer(s) agree(s) to have the puppy implanted with a COMPANION ANIMAL RECOVERY-brand microchip device. The puppy is to have the microchip registered with CAR and the registration is to include the breeder's name and phone number as alternate contact information. The breeder is to be provided with the CAR registration information for record-keeping purposes.

The buyer(s) agree(s) to bear the cost of radiographic examination of the dog's hips after the age of 2 years by a qualified veterinarian familiar with OFA radiography techniques. The buyer(s) agree(s) to bear the cost of thyroid testing for evaluation of free T4, TSH and TgAA levels and submission to the OFA using an OFA-approved laboratory for testing. Hip and thyroid testing is to occur within 6 months of [Date 2 years in the future from birthdate]. The x-ray and thyroid testing is to be submitted to the OFA for evaluation and publication of results, regardless of test results.

When the breeder receives the OFA hip and thyroid reports on this puppy and the spay/neuter certificate, AKC registration of the dog will be transferred to the buyer(s). The buyer(s) agree(s)

to promptly notify the breeder(s) of any health problems this dog may develop, to maintain proper breeding records.

The breeder may make a request for additional health testing to be performed, should any issues be documented by puppy buyers or the breeder. These additional tests are requested to assure the health of the puppies and to gather health information about the sire and dam. The cost of any additional health testing is to be borne by the buyer(s).

The buyer(s) agree(s) to socialize this puppy with adults, children and new situations in an age-appropriate manner. In addition the buyer is to enroll the puppy in age-appropriate canine Puppy Kindergarten and Beginner Obedience classes as soon as possible. We recommend the classes should use positive reinforcement and/or clicker training methods.

This dog is being sold with the intention of providing companionship to the buyer(s) for the rest of the dog's natural life. If for any reason the buyer cannot keep the dog, the buyer(s) agree(s) to return the dog to the breeder without delay. All costs to return the dog are to be borne by the buyer(s). **The dog is not to be placed with a third party or animal shelter under any circumstances.** No refund of the purchase price will be provided upon the return of the dog to the breeder outside the conditions set forth in this contract. Any returned dog will live with the breeder or be placed in a new home after a temperament and health evaluation is completed.

Sign both copies of this bill of sale and retain one copy for your records. Payment is due the day the dog is taken home.

I hereby understand and agree to all the terms and conditions set forth in this bill of sale. I understand this bill of sale is in compliance with current American Kennel Club rules. I understand that failure to comply with this bill of sale as written will mean that the AKC registration papers will not be provided for this puppy.

This dog is to be registered with the AKC with the prefix Rysan's _____ and the theme is [YET TO BE DETERMINED]. The name selection must be approved by the breeder for use in the AKC Registration process.
